# JCPS takeover simply the wrong move at wrong time

A state takeover of Jefferson County Public Schools is not the solution. Not now. Not in this way.

The recommendation of Kentucky's interim education commissioner is a clear political move, not a problem-solving proposal. A genuine proposal to fix JCPS requires meaningful input from students, parents, teachers and administrators, and from a truly diverse collection of business and nonprofit leaders. A genuine proposal to fix JCPS requires consensus on what problems we're trying to fix. A genuine proposal can come only after newly installed Superintendent Marty Pollio has had a chance to dig into the problems in a way his predecessor never did.

No one disagrees that there are major problems in JCPS, particularly with the shameful achievement gaps between some students of color and white students. But those gaps are the manifestation of deeply layered problems tied to how this country, this commonwealth and this city distribute resources and how they enforce a hierarchy that has created a permanent economic underclass disproportionately occupied by African-Americans.

A takeover also is an inappropriate infringement on local control of a district unlike any other in the commonwealth, one that we must not forget educates the vast majority of productive workers who successfully power the state's economic engine.

This takeover proposal is too much and it's way too soon.
